# Citizen Science

The next “big event” in birding is the Global Big Day on May 14, 2022. Participation is simple, but you do need an eBird account. If you do not have an eBird account, [create one here](#). To participate in the Global Big Day, just count birds! You do not have to commit to birding for 24 hours—an hour or even 10 minutes of watching birds makes you part of the team. Visit your favorite spot or search out someplace new; enjoy a solo walk or get some friends to join in the Global Big Day fun.

Enter the birds that you see and hear via the eBird website or the eBird app on your cellphone. You can enter and submit lists while you are still out birding, and the app will even keep track of how far you have walked, so you can focus on watching birds. It is that simple!

Want to participate in additional citizen science projects? If you want one related to birds, visit the Cornell Lab of Ornithology [Citizen Science](#) page. There are numerous projects to choose from. With nesting season underway in Florida, NestWatch might be a good choice.

## Feathered Friends

Recent news is not good for our avian friends in Florida. The Florida Fish and Wildlife Conservation Commission (FWC) has been notified by the National Veterinary Services Laboratory of confirmed cases of Highly Pathogenic Avian Influenza (HPAI) strain: H5 2.3.4.4 in lesser scaup, black vultures, royal terns, and bald eagles. Presence has been confirmed in dead birds from Palm Beach, Brevard, and Volusia counties. Tests are pending for pelicans, herring gulls, crows, and screech owls. There are also northern gannet deaths reported but these may be natural mortalities during migration.

The H5.2.3.4.4 virus affects a wide range of bird species and caused a large number of avian deaths in the Carolinas, Virginia, and Canada in 2021. Now the virus has arrived in Florida. How can you help prevent the spread of this virus?

1. **Do not handle dead or dying birds!**
2. Notify FWC of all bird mortalities via this [link](#).
3. Keep your bird baths and bird feeders scrupulously clean and disinfected or take them down.

Wildlife rehabilitation facilities may refuse the intake of ill birds from the general public at this time. If you find a bird that is obviously sick call the local government animal services number. Do not bring sick birds to a local wildlife rehabilitator without calling first to ask if they are accepting birds. I know this is distressing for bird lovers, but this disease is very transmissible amongst birds and has a very high mortality rate. Let's hope the disease passes quickly and with little damage to our beautiful Florida birds.
